THIS CONTRACT, made this JUL 08 2022 day and between:

**PHILIPPINE NATIONAL POLICE**, a law enforcement agency of national government created and existing by virtue of and pursuant to RA No. 6975, as amended by RA No. 8551, its Police Regional Headquarters located at Camp BGen Vicente P Lim, Calamba City represented by **POLICE BRIGADIER GENERAL ANTONIO C YARRA, REGIONAL DIRECTOR, PRO4A** herein referred to as the "Procuring Entity";

-and-

**RGP ENTERPRISES**, a duly registered entity pursuant to Act 3883, as amended by Act 4147 and Republic Act No. 863 with office address at 152-C Scout Gandia Street, Brgy Sacred Heart, Quezon City represented by **MR. JUAN RICARDO LOPEZ PIMENTEL**, herein referred to as the "Supplier".

**NOW THIS CONTRACT WITNESSETH** as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- Annex A - the Bid Form and Price Schedule submitted by the Bidder;
- Annex B - the Schedule of Requirement;
- Annex C - the Technical Specifications;
- Annex D - the General Conditions of Contract;
- Annex E - the Special Conditions of Contract;
- Annex F - the Entity's Notification of Award; and
- Annex G - the Performance Security.

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier thereby covenants with the Entity to provide the goods for a period of Thirty (30) calendar days with a Contract Amount of **One Million Three Hundred Sixty- Seven Thousand Nine Hundred Thirty- Six Pesos (Php1,367,936.00)**.

4. The price shall be fixed from the time it was offered during the Opening of Bids until the completion of the contract. Any amendments or changes in the prices due to seasonal changes in the market demand shall immediately be communicated to the Buyer for adjustments which shall not be more than 5% of the original price offered.

5. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract price or such other sum as may become payable, under the provisions of the contract at the time and in the manner prescribed by this contract.


