**Invitation to Bid for the PRO4A Command Centers
(Establishment and Upgrade of 4 Command Centers)**

(PNP-PRO4A-CC4)

1. The Police Regional Office 4A, through the General Appropriations Act (GAA) FY 2022 intends to apply the **ICT Software** amounting to **One Million Nine Hundred Forty Thousand Pesos (Php1,940,000.00)** and **ICT Equipment** amounting to **Thirty-Three Million Six Hundred Seventy-Four Thousand Two Hundred Ninety Pesos (Php33,674,290.00)**. The sum of **Thirty-Five Million Six Hundred Fourteen Thousand Two Hundred Ninety Pesos (Php35,614,290.00)**, being the Approved Budget for the Contract (ABC) for the **PRO4A Command Centers (Establishment and Upgrade of 4 Command Centers)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Police Regional Office 4A now invites bidders for the above Procurement Project. Delivery of Goods is required within **180** calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.


Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Interested Bidders may obtain further information from the Bids and Awards Committee (BAC) thru the BAC Secretariat and inspect the Bidding Documents at **RLRDD Office Camp BGen Vicente Lim, Mayapa, Calamba City from Monday to Friday 8:00 AM to 5:00 PM.**
5. A complete set of Bidding Documents may be acquired by interested Bidders from November 21, 2022 to November 25, 2022 from the address provided below upon payment of a non-refundable fee amounting to **Twenty-Five Thousand Pesos (P25,000.00)**.

6. The Police Regional 4A will hold a Pre-Bid Conference¹ on November 18, 2022, 2:00 PM at PRO 4A MPC Hall, Camp BGen Vicente Lim, Mayapa, Calamba City, which shall be opened to all prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the **Regional Logistics Research and Development Division (RLRDD), Camp BGen Vicente Lim, Mayapa, Calamba City on or before November 28, 2022 at 9:00 AM.** Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be **on November 28, 2022, 2:00 PM at PRO 4A MPC Hall, Camp BGen Vicente Lim, Mayapa, Calamba City.** Bids will be opened in the presence of the bidders' authorized representatives who choose to attend the activity.
10. The Police Regional Office 4A reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
