Invitation to Bid for the Procurement and Installation of One (1) Set of Hybrid Photovoltaic System for Tagkawayan MPS (TAGKAWAYAN0806-4)


1. The Police Regional Office 4A (PRO4A), through the PNP Trust Receipts Fund Board intends to apply the sum of **One Million Four Hundred Sixty Thousand Pesos (Php1,460,000.00)**, being the Approved Budget for the Contract (ABC) for the Procurement and Installation of One (1) Set of Hybrid Photovoltaic System for Tagkawayan MPS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Police Regional Office 4A (PRO4A) now invites bidders for the above Procurement Project. Completion of Works is required within **15** calendar days upon receipt of Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested Bidders may obtain further information from the Bids and Awards Committee (BAC) thru the BAC Secretariat and inspect the Bidding Documents at **RLRDD Office Camp B Gen Vicente Lim, Mayapa, Calamba City from Monday to Friday 8:00 AM to 5:00 PM.**
5. A complete set of Bidding Documents may be acquired by interested Bidders from August 9, 2021 to August 25, 2021 from the address provided below upon payment of a non-refundable fee amounting to Five Thousand Pesos (**Php5,000.00**).
6. **The Police Regional Office 4A (PRO4A) will hold a Pre-Bid Conference¹ on August 13, 2021, 9:00 AM at PRO4A MPC Hall, Camp BGen Vicente Lim, Mayapa, Calamba City** which shall be opened to all prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the **PRO4A Multi-Purpose Center Hall**, Camp BGen Vicente Lim, Mayapa, Calamba City on or before **August 25, 2021 at 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
9. Bid opening shall be on **August 25, 2021, 9:00 AM** at **PRO4A MPC Hall, Camp BGen Vicente Lim, Mayapa, Calamba City**. Bids will be opened in the presence of the bidders' authorized representatives who choose to attend the activity.
10. The Police Regional Office 4A (PRO4A) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
