4	Can we submit a Bank Deposit Certificate instead of the Net Financial Contracting Capacity since the banks are no longer issuing the latter due to the pandemic and for the purpose respectfully request for issuance of SBB?	As stated in the Bidding Documents: For purposes of determining the eligibility of a prospective bidder, a bidder may submit a Committed Line of Credit (CLC) from Universal or Commercial Bank which is equal to or at least ten percent (10%) of the ABC or Php1,103,652.08, in lieu of its Net Financial Contracting Capacity. <i>Provided</i> , that if the same is issued by a foreign Universal or

		Commercial Bank, it shall be confirmed or authenticated by a local Universal or Commercial Bank. [Section 23.4.1.5, RIRR of RA No. 9184] (Amendment of para 18 to read as 18.4) The SBB will be issued at least 7 calendar days before the Opening of Bids
5	For the delivery of goods, respectfully request for an extension in the delivery date from 30 to 90 days?	The request cannot be granted. The training period will not adjust to the supplier, because it has to be finished everyday, every week, every month. It has to be respected for the purpose, that is why the BAC already determined and planned for the budget and activity. We expect from the supplier that we are also equal on what we need because the End-user, the Training Schools is in dire need of ammunitions and thus, cannot wait because it will take a long time of the required date to accomplish that we cannot compromise any delay.

All terms, conditions and instructions to bidders specified in the Bidding Documents inconsistent with this Bid Bulletin are hereby amended, modified and superseded accordingly.
